further to amend the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances, Privileges and Pension of the Members) Act, 1975

Whereas, it is expedient to amend the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances, Privileges and Pension of the Members) Act, 1975 (Act XX of 1975), for the purposes hereinafter appearing;

It is hereby enacted as follows:-

- 1. Short title and Commencement.**— (1) This Act may be called the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances, Privileges and Pension of the Members) (Amendment) Act, 2017.
(2) It shall come into force at once and shall be deemed to have taken effect from 1st day of June, 2017.
- 2. Amendment of Section 7-B (Act XX of 1975).**— In the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances,

Privileges and Pension of the Members) Act, 1975 (Act XX of 1975), in Section 7-B, between the words “on” and “official” the words “thirty five percent of the” shall be inserted.

3. **Amendment of Section 11-A (Act XX of 1975).**- In the said Act, in Section 11-A, in proviso to clause (i), for the words “one lac” the words “one lac twenty thousand rupees per month shall be substituted”.
4. **Amendment of Section 12-C (Act XX of 1975).**- In the said Act, in Section 12-C, the full stop at the end of last proviso shall be substituted by a colon (:) and thereafter following new proviso shall be added:-

“Provided further that the provisions of this Section shall take effect from 1st day of July, 2006.”
