No. LD/Legis-Act/ 550-63/2017. The following Act of Assembly received the assent of the President on the 7th day of September 2017, is hereby published for general information.

further to amend the Azad Jammu and Kashmir Legislative Assembly Speaker (Salary, Allowances and Privileges) Act, 1975

Whereas, it is expedient further to amend the Azad Jammu and Kashmir Legislative Assembly Speaker (Salary, Allowances and Privileges) Act, 1975 (Act XVII of 1975) in the manner hereinafter appearing;

It is hereby enacted as follows:-

- 1. Short title and Commencement.**-(1) This Act may be called the Azad Jammu and Kashmir Legislative Assembly Speaker (Salary, Allowances and Privileges) (Amendment) Act, 2017.
(2) It shall come into force at once and shall be deemed to have taken effect from 1st day of June, 2017.
- 2. Amendment of Section 3, (Act XVII of 1975).**- In the Azad Jammu and Kashmir Legislative Assembly Speaker (Salary, Allowances and Privileges) Act, 1975 (Act XVII of 1975), hereinafter referred to as the said Act, in Section 3, for sub-section (1) following shall be substituted:-
“(1) The salary of the Speaker shall be one lac fifty thousand rupees per mensem.”

3. **Amendment of Section 4, (Act XVII of 1975).**- In the said Act, in Section 4, for the words “ten thousand”, the words “thirty thousand” shall be substituted.
4. **Amendment of Section 6, (Act XVII of 1975).**- In the said Act, in Section 6, for the words “twelve thousand”, the words “fifty thousand” shall be substituted.
5. **Amendment of Section 11, (Act XVII of 1975).**- In the said Act, in Section 11, for the words “three thousand”, the words “four thousand” shall be substituted.
6. **Addition of Section 11-A, (Act XVII of 1975).**- In the said Act, after Section 11, following new Section 11-A shall be added:-
“11-A. Dearness Allowance.-The Speaker shall be entitled to receive Dearness Allowance at the rate of fifteen thousand rupees per mensem.”
7. **Amendment of Section 14, (Act XVII of 1975).**- In the said Act, in Section 14, after the word “Speaker” wherever occurring the words “or Ex-Speaker” shall be inserted.
8. **Amendment of Section 15, (Act XVII of 1975).**- In the said Act, in Section 15, in sub-section (2) for the words “thirty seven thousand”, the words “one complete pay” shall be substituted.
9. **Amendment of Section 21, (Act XVII of 1975).**- In the said Act, in Section 21, for the words “five lac”, the words “ten lac” shall be substituted.
