No. LD/Legis- Act/440-52/2014, The following Act of Assembly received the assent of the President on 19th day June, 2014, is hereby published for general information.

[Act XXVIII of 2014]

An Act

to amend the Superior Court (Court Dress and Mode of Address) Act 1986.

Whereas, It is expedient to amend the Superior Courts (Court Dress and Mode of Address) Act, 1986 (Act XXVIII of 1986), for the purposes hereafter appearing:

It is hereby enacted as follows:-

- **Short title and Commencement.** (1) This Act may be called the Superior Court Dress and Mode of Address) (Amendment) Act, 2014.
 - (2) It shall come into force at once.
- **Amendment of Section 2, Act XXVII of 1986.** In the Superior Courts (Court Dress and Mode of Address) Act 1986, (Act XXVII of 1986), hereinafter referred to as the said Act, in Section 2, following amendments shall be made:-
 - (i) Clause (b) shall be substituted as under:-

- "(b)" "Judge" means a Judge of the Superior Court; and"
- (ii) After Clause (b), as amended above, following new clause (c) shall be added:"(c) "Chief Justice" means a Chief Justice of the Superior Court.
- **Amendment of Section 3, Act XXVIII of 1986**. In the said Act, the existing Section 3, shall be substituted as under:-
 - **Court Dress** .- The Chief Justice and a Judge shall wear while he is attending sittings of the Superior Court:-
 - (a) In Summer:-
 - (i) a black sherwani without bands, white shalwar or pyjama or a shourt coat of black material: or
 - (ii) white shirt, with tum-down color and black tie, white trousers, and
 - (b) In winter, trousers of material in the deeper shades of gray and a black gown.-
 - (i) with two golden color strips on the both sides in length on front and collar, three like color strips on both arms for the gown of a Chief Justice;
 - (ii) with one golden color strip on the both sides in length on front and collar, two like color strips on both arms of the gown for a judge."
- **4.** Amendment of Section 4, Act XXVIII of 1986. In the said Act, in Section 4, before the word "Judge" the words and a letter "Chief Justice and/or a" shall be inserted.
